How to Read the Report

<u>AL = Action Level</u>: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

 $\underline{MCL} = \underline{Maximum Contaminant Level}$: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

 $\underline{MCLG} = \underline{Maximum Contaminant Level Goal}$: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

<u>MDL = Method Detection Limit</u>: The minimum amount of a substance (contaminant) that needs to be present in order to be detected.

<u>ppm = parts per million</u>: Means 1 part per 1,000,000 (same as milligram per liter) and corresponds to 1 penny in 10 thousand dollars.

ppb = parts per billion: Means 1 part per 1,000,000,000 (same as microgram per liter) and corresponds to 1 penny in 10 million dollars.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children.
